VACATION OF A PORTION OF A STREET

KNOW ALL MEN BY THESE PRESENTS: That, WHEREAS, the undersigned, LESLIE T. FICKLING and ANNETTE G. FICKLING, husband and wife, are the owners of Lot Three (3), Block Eleven (11) as shown on a certain Map or Plat entitled "Pinewood Shores", duly recorded in the office of the Judge of Probate, Baldwin County, Alabama in Map Book 4, page 15, and

WHEREAS, lot Three (3), Block Eleven (11) in Pinewood Shores abuts a portion of that certain street or right of way designated and named Bayside Drive as shown on said map or plat; said portion of Bayside Drive lying between Lot 3, Block 11 in Pinewood Shores and Miflin Creek, and

WHEREAS, said portion of Bayside Drive is not within the limits of any municipality and has not been used, nor is it being used, as a public road, and

WHEREAS, a Vacation of said portion of Bayside Drive will not deprive other property owners of such right as they may have to convenient and reasonable means of ingress and egress to and from their property,

NOW, THEREFORE, the undersigned do hereby declare that certain portion of Bayside Drive abutting Lot Three (3), Block Eleven (11) of Pinewood Shores, hereinafter more particularly described, to be VACATED, CANCELED, ANULLED AND DISCHARGED OF RECORD:

Beginning at the Southwest corner of Lot Three (3), Block Eleven (11) of Pinewood Shores at Peterson's Point situated in the Southeast Quarter (SE $\frac{1}{4}$) of Section Seven (7), Township Eight (8) South, Range Five (5) East, thence run 155.8 feet to the Northwest corner of said Lot Three (3) of Block Eleven (11), thence run North 79° West to Miflin Creek, thence run Southwesterly along the meanderings of Miflin Creek 155.8 feet, more or less, to a point North 79° West of the point of beginning, thence run South 79° East to the point of beginning, intending to describe all of that land lying between said Lot Three (3), Block Eleven (11) and Miflin Creek.

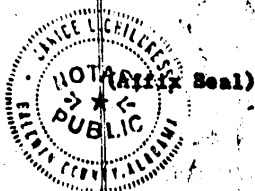
