



Addendum to Vacant Land Contract

When initialed by all parties, the parties acknowledge that the disclosure set forth below was provided to the Buyer prior to the execution of the Vacant Land Contract between the parties and the clauses below will be incorporated therein: Steven L. Homeowners' Association:** The Property is located in a community with a ☐ voluntary ☐ mandatory (see the Disclosure Summary below) homeowners' association ("Association"). **Seller's** due diligence period, if any, under Paragraph 9 of this Contract, and risk of loss under Paragraph 12 of this Contract, extend only to the Property and does not extend to common areas or facilities described below.

1. Association Approval: If the Association documents give the Association the right to approve **Buyer** as a purchaser, this Contract is contingent on such approval by the Association. **Buyer** will apply for approval within _____ days (5 days if left blank) after Effective Date and use diligent effort to obtain approval, including making personal appearances and paying related fees if required. **Seller** and **Buyer** will sign and deliver any documents required by the Association to complete the transfer. If **Buyer** is not approved, this Contract will terminate; and **Buyer's** deposit(s) will be refunded unless this Contract provides otherwise.

2. Right of First Refusal: If the Association has a right of first refusal to buy the Property, this Contract is contingent on the Association deciding not to exercise such right. **Seller** will, within 3 days after receipt of the Association's decision, give **Buyer** written notice of the decision. If the Association exercises its right of first refusal, this Contract will terminate, **Buyer's** deposit(s) will be refunded unless this Contract provides otherwise, and **Seller** will pay broker's full commission at Closing in recognition that broker procured the sale.

3. Fees: **Buyer** will pay any application, transfer, and initial membership fees charged by the Association. **Seller** will pay all fines imposed against the Property as of Closing and any fees the Association charges to provide information about its fees or the Property and will bring maintenance and similar periodic fees and rents on any recreational areas current as of Closing. If, after Effective Date, the Association imposes a special or other assessment for improvements, work, or services, **Seller** will pay all amounts due before Closing and **Buyer** will pay all amounts due on or after Closing. If special assessments may be paid in installments ☐ **Seller** ☐ **Buyer** (**Buyer** if left blank) will pay installments due after Closing. Damage to Common Elements: If any portion of the common elements is damaged due to fire, hurricane, or other casualty before Closing, either party may cancel this Contract and **Buyer's** deposit(s) will be refunded if (i) as a result of damage to the common elements, the Property appraises below the purchase price and either the parties cannot agree on a new purchase price or **Buyer** elects not to proceed, or (ii) the Association cannot determine the assessment attributable to the Property for the damage at least 5 days before Closing, or (iii) the assessment determined or imposed by the Association attributable to the Property for the damage to the common elements is greater than \$ _____ or _____% (1.5% if left blank) of the purchase price.
